THE PROJECT WAS COMPLETED IN MAY 2008 AND OCCUPANCY BEGAN IN JUNE 2008. THE PROJECT IS OPERATED UNDER SECTION 202 OF THE NATIONAL HOUSING ACT, AS AMENDED. SUCH PROJECTS ARE REGULATED BY THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) AS TO RENT CHARGES, OPERATING METHODS AND USE OF ASSETS. HUD AND VARIOUS OTHER AGREEMENTS ARE IN PLACE WHICH DICTATE MAXIMUM INCOME LEVELS OF TENANTS AND PROVIDE RENT RESTRICTIONS THROUGH THE YEAR 2048.
